CRG Networks and the Cochrane Community: Working better together

At its meeting in Cape Town, in September 2017, Cochrane's Governing Board approved the Cochrane Review Group (CRG) <u>Transformation Programme Implementation Plan</u>. This plan sets out the changes we will be making to ensure Cochrane addresses the challenges it faces in relation to the production of a comprehensive collection of timely, high-quality Cochrane Reviews, relevant to our stakeholders.

Within the first three months of 2018, we have seen the formation of our eight thematic <u>CRG</u> <u>Networks</u>, which will comprehensively cover all healthcare topics. The new CRG Networks provide an opportunity to optimize resources, support and leadership.

During the Strategic Session we welcome the Cochrane community to come together and discuss key objectives for CRG Networks in 2018, focusing on priority-setting; improving consistency in review quality; innovations; and support and mentoring for authors, CRGs, and Networks. The session will be a genuine opportunity to influence the decisions and direction taken for the Networks in 2018.

Following the Governance Meetings, there will be a series of CRG Network webinars with an invitation to the wider community to ensure that all Cochrane's contributors are aware of the plans for 2018.

Aim of the session:

Working better together: how can the Cochrane Community support the new CRG Networks in achieving their priorities in the first year?

Priorities for the CRG Networks:

Networks will need to consider the **prioritization** of topics within their scope. This will ensure that the reviews which a Network produces are those that are most important to stakeholders. Each CRG will be encouraged to actively prioritize its reviews; the Network may adopt common or shared approaches to the selection of review topics.

Working together, under the leadership of the **Senior Editor** and supported by organizational investment in editorial, management, training, and general structures, the CRGs within a Network will ensure the **consistent quality** of their outputs and the **efficiency** of their editorial processes.

Networks provide an opportunity to foster systems that can **innovate** and scale up changes reliably. Networks may also **advocate for learning programmes** that meet the specific needs of their CRGs more effectively. CRGs will work with others in their Networks – and when appropriate, with other Networks – to ensure maximum **impact** for their reviews. Senior Editors will be encouraged to work with CRGs within a Network to seek opportunities to undertake joint funding applications and advocacy activities where appropriate.

Small Group Work
