2) Cochrane Handbook for Systematic Reviews of Interventions – NEW CHAPTERS

3) Cochrane Review Support Programme (CRSP) funding: 12 successful titles

We are pleased to announce the 12 successful titles from the fourth Cochrane Review Support Programme (CRSP) funding round:

- Adverse events in patients taking macrolide antibiotics versus placebo for any indication (Cochrane Acute Respiratory Infections)
- Cognitive behaviour therapy versus standard care for schizophrenia (Cochrane Schizophrenia)
- 3. Continence outcomes in pelvic organ prolapse surgery (Cochrane Gynaecology and Fertility)
- 4. Fluoride toothpastes of different concentrations for preventing dental caries (Cochrane Oral Health)
- 5. Methods of consumer involvement in developing healthcare policy and research, clinical practice guidelines and patient information material (Cochrane Consumers and Communication)
- 6. Mobile phone based interventions for improving adherence to medication prescribed for the primary prevention of cardiovascular disease (Cochrane Heart)
- 7. Peri-operative interventions in pelvic organ prolapse surgery (Cochrane Gynaecology and Fertility)
- 8. Saline irrigation for allergic rhinitis (Cochrane ENT)
- Selective noradrenaline re-uptake-inhibitors (SNRIs) for attention deficit hyperactivity disorder (ADHD) in adults (Cochrane Developmental, Psychosocial and Learning Problems)
- 10. Surgery for women with posterior compartment prolapse (Cochrane Gynaecology and Fertility)
- 11. Treatment for lupus nephritis (Cochrane Kidney and Transplant)
- 12. Very early versus delayed mobilisation after stroke (Cochrane Stroke)

We received 17 applications (19 reviews) from 13 groups. To evaluate the applications we convened an international assessment panel comprised of nine Cochrane contributors and consumers of Cochrane reviews, who generously shared their time and expertise:

Every year Cochrane awards members of its community a range of prizes that highlight high-quality methodological research through to supporting health decision-making in developing countries, and contributors who have made a significant contribution to the enhancement of female participation within our organization. The prizes and awards that are presented at the

annual Colloquia will this year be awarded at the <u>Global Evidence Summit</u> in Cape Town, South Africa on 14 September.

7) Cochrane Scientific Committee - UPDATE

The Scientific Committee met for the first time on the 18th May 2017. A successful meeting started with members agreeing their terms of reference and processes. The committee discussed three key new developments: "Risk of Bias" tool 2.0, the risk of bias tool for nonrandomized studies (ROBINS-I), and statistical techniques to address Type I and II errors in cumulative meta-analyses. The committee will provide statements of their recommendations shortly. We also hope to confirm shortly the names of two Co-chairs to support this committee's work.

10) GRADE and GRADE-CERQual training event - outcomes

A successful training event led by Holger Schunemann and Claire Glenton provided up to date information on applying GRADE to both effectiveness reviews and reviews synthesizing qualitative research and covered joint principles. Forty-five participants from Iran, Syria, Malaysia, India, Australia, Canada, US and Europe attended this event in Modena, Italy and we are grateful to our hosts at Cochrane Italy Centre for supporting this event and in particular, Centre director Roberto D'Amico.

11) Living Systematic Reviews are going live!

Cochrane's <u>Project Transform</u> team, in partnership with the LSR Network, have been working away for some time on the methods, and production and publication processes needed for Cochrane to be able to pilot Living Systematic Reviews (LSRs). After successful meetings and events at the Cochrane Colloquium in Seoul, and a recent two-day workshop following the Canadian Cochrane Symposium, the pilots are very nearly 'go for launch'!
