1) TDR stipends for knowledge managers in LMICs to attend Global Evidence Summit – BY TODAY!

TDR, the Special Programme for Research and Training in Tropical Diseases, is a global programme of scientific collaboration that helps facilitate, support and influence efforts to combat diseases of poverty. It is hosted at the World Health Organization (WHO), and is sponsored by the United Nations Children's Fund (UNICEF), the United Nations Development Programme (UNDP), the World Bank and WHO. TDR is offering a limited number of bursaries for researchers, policy-makers and others contributing to knowledge translation activities or evidence to policy work, preferably from Low and Middle-Income Countries (LMICs), preferably working with neglected tropical diseases, to attend the Global Evidence Summit (GES).
