## Report of comments received on Cochrane Reviews, 2016

Cochrane welcomes comments as they help to improve the quality of Cochrane Reviews and Protocols. This report covers comments submitted during 2016.

### Introduction

Users of the *Cochrane Database of Systematic Reviews* are able to submit their comment on Cochrane reviews or Protocols by completing a form on the Cochrane Library website (<a href="http://www.cochranelibrary.com">http://www.cochranelibrary.com</a>) or via an analogous system on OVID.

Submitted comments are managed and screened by an editorial team at Wiley. Any comment that is coherent and relates to the content of a Cochrane Review or Protocol is passed on to the relevant Cochrane Review Group (CRG). The CRG decides how to respond and what action to take as a result. Comments may or may not be published. The Cochrane Editorial Unit oversees this process.

Cochrane welcomes comments as they help to improve the quality of Cochrane Reviews and Protocols. This report covers comments submitted between 1 January and 31 December 2016.

## How many comments were submitted?

In 2016, the Wiley team processed 162 submitted comments. 113 of these were 'approved', i.e. passed to CRGs (Table 1).

The total number of approved comments has decreased by 14% from 2015 (Table 2)

### Where were the comments submitted?

In 2016, all 162 comments were submitted through the Cochrane Library (100% of total submissions).

### **Unapproved comments**

Unapproved comments were not forwarded to CRGs. They include:

- Comments that were offensive, nonsensical or inconsequential
- Comments that were spam, duplicates, or empty text fields
- Comments that were submitted specifically to the test system
- Comments that did not reference a specific Cochrane Review

### **Approved comments**




Figure 1: Approved CDSR comments submitted during 2016

The 113 approved comments were spread over the year as shown in Figure 1.

### Which Review Groups received the most feedback?




Figure 2: Frequency of comment submission by CRG

Cochrane Reviews are maintained by one of 52 CRGs. In 2015, 37 out of these 52 CRGs (71%) received comments. There was considerable variation in the number of comments received by each CRG (Figure 2).

- 9 CRGs received 5 or more comments
- 14 CRGs received 2 4 comments
- 14 CRGs received 1 comment
- 15 CRGs received no comments

### Where do comments come from?

Commenters are not asked for their primary country of residence on the feedback forms, and this information is not tracked.

### Who do comments come from?

Commenters are encouraged to state their role and affiliation but it was difficult to categorize the information provided as there was no standardized format. Contributors were a mix of generalist and specialist, academic and clinical, Cochrane and non-Cochrane.

## What happens to comments after they have been sent to the Review Group?

CRGs are encouraged to respond to all feedback sent their way.
