1. Call for nominations: Invitation to stand for election to the Governing Board: Deadline 15 July 2018

Cochrane's Governing Board is seeking to elect a new member. Cochrane is an international organization and a registered charity in the UK, and members of the Governing Board from around the world are 'Trustees' of the charity. It is important to note that Cochrane Governance Meetings are usually held in Europe, where the location should be within two hours' travelling time of an international airport; but they can also be held elsewhere in the world, though at an easily accessible transport hub.

The aim of the Cochrane KT's 'Improving and Upscaling Products' Working Group is to document current dissemination products across Cochrane and to identify and prioritize those products or activities for further improvement and development. In order to achieve this aim, our Working Group has developed a survey to try to capture this information.

6. Letter from the CEO: New line management arrangements for Cochrane Networks & Centres

Dear Directors of Centres, Associate Centres and Affiliates,

I wanted to let you know about a change I am making in the responsibility for direct management and support of Cochrane's Centres (and through them, other geographic Groups).

Having established the accountability relationships and mechanisms of Cochrane Centres to Cochrane's Central Executive over the last couple of years, it has become clear to me in the last few months that I am unable to give the time and attention that is and will be required to guide, support and manage the work of the Directors of Cochrane Networks and Centres (and their management of their Centre teams, Cochrane Associate Centres and Affiliates) to meet the knowledge translation, community support, representative and advocacy challenges that will become the main focus of Cochrane Centres in the coming years. These are tremendously exciting times for Cochrane's geographic-oriented Groups as we look to strengthen their engagement and interactions with Cochrane Review Groups and Fields; and ensure that Cochrane evidence is known and used in healthcare policy and practice more often – and in more countries – than ever before. To be successful Cochrane's Central Executive will need to provide you with a level of engagement and support that is much greater than in the past – and this is especially the case as we also work to establish new or improved Cochrane Networks in the US, China and South Asia.

I've therefore decided, with the support of both my Senior Management Team and Cochrane's Governing Board Co-Chairs, to pass on the responsibility for direct line management of Cochrane's Centres and geographic Networks to Sylvia De Haan (<u>sdehaan@cochrane.org</u>), my new Senior Advisor for Centres, Partnerships & Fundraising. Sylvia is based in the CEO's Office and will work closely with me (and continue to be supported by me for key strategic and tactical choices and issues). Sylvia brings great experience to the role; and her knowledge and involvement in the KT strategy and leadership of Cochrane's organizational partnership and external engagement means that she's perfectly placed to support Cochrane Centres in your own increased efforts in these critical areas. Sylvia is also so much more organised and efficient in her work that I'm sure guidance and support to the Centres will improve considerably! She'll take a leading role co-chairing the Centre Directors Executive, working with Erik Von Elm and Lotty Hooft (the Council reps and other Co-Chairs). We plan to participate together with each of you for the next round of quarterly meetings, after which Sylvia will meet directly with each of you on a regular basis.

I hope you'll join me in welcoming Sylvia to this new role and I'm grateful for all of the support that you can give her as she gets to know the details about the work of you and your Centre, as well as any Associate Centres and Affiliates. I've enjoyed enormously the many interactions I've had with Cochrane Centre Directors and your staff over the last five and a half years; and be assured that these will continue in future. I remain available at any time – as now – for anybody who wants to raise issues with me directly, whilst expecting most issues of a Centre's business to be covered by you and Sylvia in the first instance. Nevertheless, please let me know if you have any questions or concerns.
