

Terms and Conditions of Use – Cochrane Library Data

1. Copyright

Cochrane Reviews, Cochrane Protocols and associated statistical datasets (together, the “Data”) are published by John Wiley & Sons Limited (“Wiley”) on behalf of the Cochrane Collaboration under an exclusive licence from the authors. Copyright in the Data remains the sole property of the authors or third party rightsholders who have granted permission for their material to be used in the Data. To the extent that the Cochrane Collaboration has the right to do so, it grants you permission to use the Data in accordance with these Terms and Conditions of Use.

2. Licence terms

Subject to the other provisions of these Terms and Conditions of Use:

- (a) For Data subject to a standard Licence for Publication, the Cochrane Collaboration grants you a non-exclusive, non-transferable, non-sublicensable, non-commercial, royalty-free, world-wide licence to use the Data during the Use Period set out in Schedule 1 for the research and development purpose set out in Schedule 1 (“Purpose”) only; and/or
- (b) For Data subject to a Creative Commons Licence, you may use the Data in accordance with the terms of the applicable type of licence set out in the table below. See creativecommons.org/licenses for additional information.

Type of licence	Description
CC BY (Attribution)	This licence allows others to distribute, remix, tweak and build upon an author's work as long as the author is credited for the original work. This license permits commercial and non-commercial reuse.
CC BY-NC (Attribution, non-commercial)	This license lets others remix, tweak, and build upon an author's work non-commercially, and although their new works must also acknowledge the author and be non-commercial, they don't have to license their derivative works on the same terms.
CC BY-NC-ND (Attribution, non-commercial, no derivatives)	This license allows others to download an author's work and share it with others as long as they credit the author, but they can't change the work in any way or use it commercially.

It is your responsibility to check the metadata for the Data to determine which licence is applicable.

The Data must not be incorporated into the outputs of the Purpose. You must be able to use those outputs independently of the Data.

You will only be permitted to share the Data with the other investigators set out in Schedule 1 and only to the extent necessary to enable you to carry out the Purpose. You will keep the Data safe and secure.

3. Unauthorised use

Any use by you of any Data beyond the scope of the licence terms set out in paragraph 2 above, shall be a material breach of these Terms and Conditions of Use and the Cochrane Collaboration reserves the right to suspend or terminate

your access to the Data and/or require you to return or destroy the Data immediately without notice, in addition to any other available remedies.

4. Correct citation and acknowledgement and publication

In respect of any use of the Data you must acknowledge the source of the Data. You must send a copy of any publication or other output produced using the Data ("Output") to support@cochrane.org and you will only publish any Output in the places identified in Schedule 1.

5. No Endorsement/Association

You may not publicly represent or imply that The Cochrane Collaboration is participating in, or has sponsored, approved or endorsed the manner or purpose of your use or reproduction of the Data. You may not use any trade mark, official mark, official emblem or logo of the Cochrane Collaboration, or any of its other means of promotion or publicity, without the Cochrane Collaboration's prior written consent nor in any event represent or imply an association or affiliation with Cochrane.

6. Notification of errors

You must notify the Cochrane Collaboration promptly in writing of any errors discovered in the Data so that the author(s) can be alerted.

7. Third party data

Data provided under these Terms and Conditions of Use may contain or be derived in whole or in part from third party data ("Third Party Data"), as identified in the Data. If you want to use Third Party Data for any purpose that is not expressly permitted under these Terms and Conditions of Use you will need to obtain permission from the Third Party in respect of such use.

8. No warranties

The Data is provided on an "as is" basis without warranties of any kind, either express or implied, including without limitation warranties of title or implied warranties of merchantability or fitness for a particular purpose, or that the Data is accurate, complete and up to date. You hereby acknowledge that use of the Data is at your sole risk and that the Data may not be error-free.

9. Data protection

Both parties will comply with their obligations under the Data Protection Legislation. In these Terms and Conditions of Use, "Data Protection Legislation" means the General Data Protection Regulation ((EU) 2016/679) and the UK Data Protection Act 2018 and any successor legislation to them, and all other legislation and regulatory requirements in force from time to time which apply to a party relating to the use of personal data (including, without limitation, the privacy of electronic communications).

10. Indemnity

You hereby indemnify the Cochrane Collaboration, and its employees, agents, representatives, officers and directors, against all claims, liability, damages, costs and expenses, including legal fees and expenses, arising out of any use of Data beyond the scope of the rights granted in these Terms and Conditions of Use, or any use of any Data which has been altered in any way by the User, including claims for defamation or infringement of intellectual property rights (including without limitation copyright, patent or trademark rights) or rights of privacy.

11. Limitation of liability

To the fullest extent permitted by law, the Cochrane Collaboration will not be liable to you for any direct, indirect, consequential or incidental damages (including without limitation damages for loss of business profits or information, or for business interruption) arising out of (i) your use of the Data or (ii) your inability to obtain additional rights to the Data.

12. Term and Termination

These Terms and Conditions of Use shall take effect from the date the last party signs them and shall continue in full force and effect unless terminated by the Cochrane Collaboration in accordance with this paragraph. The Cochrane Collaboration may terminate these Terms and Conditions of Use:

- (a) At any time by giving 30 days' notice in writing to you; or
- (b) Immediately by giving notice in writing to you if you breach these Terms and Conditions of Use.

On termination of these Terms and Conditions of Use you shall return or destroy (at the Cochrane Collaboration's discretion) the Data.

13. Notices

(a) Any notice or other communication given to a party under or in connection with these Terms and Conditions of Use shall be in writing and shall be:

(i) delivered by hand or by pre-paid first-class post or other next working day delivery service to the recipient's Address; or

(ii) sent by email to the recipient's Email Address.

(b) Any notice or communication shall be deemed to have been received:

(i) if delivered by hand, on signature of a delivery receipt or at the time the notice is left at the Address;

(ii) if sent by pre-paid first-class post or other next working day delivery service, at 9.00 am on the second Business Day after posting or at the time recorded by the delivery service;

(iii) if sent by email, at 9.00 am on the next Business Day after transmission.

In this paragraph, "Business Day" means a day, other than a Saturday, Sunday or public holiday in England, when banks in London are open for business.

(c) In this paragraph, a party's Address and Email Address is the one set out below or such other address or email address as a party notifies to the other in accordance with this paragraph.
