In June 2019, the 2018 Journal Citation Report was released by Clarivate Analytics, and we are delighted to announce that Cochrane Database of Systematic Reviews (CDSR) Journal Impact Factor is now **7.755**. This is an increase on the 2017 Journal Impact Factor, which was 6.754. This means that, in 2018, a Cochrane Review was cited on average, once every 8 minutes!
