WORK: David Hammerstein has been working since 2015 as a civil society advocate for the Commons Network, a small German NGO with offices in Berlin and Brussels of which he is co-founder that focusses on the defense of the knowledge commons and access to medicines. He also works as an advocate for the World Blind Union and the European Blind Union on issues of disability rights. From 2010 to 2015 he worked as a senior advocacy officer in Brussels for the Transatlantic Consumer Dialogue, platform of over 60 transatlantic consumer and citizens organizations, on EU and UN policy issues related to access to knowledge and access to medicines He was born in Los Angeles, USA in 1955. From 2004-2009 he was elected Member of the European Parliament where he was a member of its Industry, Research and Energy Committee where he specialized in issues related to scientific and academic research and innovation. Since 2010 he maintains no political party affiliation and focusses on paid and voluntary civil society commitments in fields of health, environment and disability rights.
