I am a Fellow at the Citizen Network, where I have written about the ways that misleading claims in medical research can relate to social and political problems, using trials that might be included in this review as examples. Since the Lancet published claims about a "strict criterion for recovery" for the PACE trial, using a criteria which overlapped with the trial's own entry criteria, I have become increasingly interested in the cultures of those institutions that many of us trust to provide accurate medical information. I first raised concerns with Cochrane about their CFS work in 2013. I have been diagnosed with CFS and done small pieces of patient engagement related to this over the last decade, some of which were more than box ticking exercises.
