Partnership Update - Quarter 1 2017

Cochrane's work with external partners is guided by the <u>Cochrane Partnership Policy</u> and the Cochrane <u>Framework for Partnership Development</u>. A <u>dedicated</u> <u>space on the community website</u> has been developed to keep the Cochrane community informed about the key external partnerships that Cochrane is engaged in. The <u>October 2016 update to the Cochrane CSG</u> on external partnerships is also available on the community site.

The current document provides a status update on Cochrane's external partnerships for Q4, 2016 and Q1, 2017. The annex provides a detailed overview per partner, also specifying the plans for the next two quarters. The main developments to note are:

- The planning for the Global Evidence Summit is progressing well and provides an opportunity to connect many of our external partners: sessions are being planned with various groups at WHO, with G-I-N, Campbell, JBI and consumer organisations.
- We ended the official partnership with the Union for International Cancer Control (UICC) due to lack of demonstrable progress.
- We signed official MoUs with Epistemonikos, G-I-N and MAGIC.
- We also signed an MoU in support of the March for Science, and will be working in the coming weeks, jointly with the US Cochrane Centre, on ensuring a Cochrane contribution to the March.
- We started using Task Exchange for work with external partners: most notably G-I-N and Wikipedia.
- The work on the Partnership Toolkit, an online resource for Cochrane Groups to use for their own partnership development, will evolve alongside the Knowledge Translation Strategy, to ensure that they are connected and complementary, and is thus scheduled to start in Q2.

New relationships that we are continuing to explore but are not yet far enough along to be included in the table in the Annex below include:

- 'Choosing Wisely' is a campaign to help clinicians and patients engage in conversations about unnecessary tests and treatments and make smart and effective choices to ensure high-quality care. We have reached out to <u>Choosing Wisely international</u>, and to Choosing Wisely Netherlands, and are exploring how we can contribute to the Choosing Wisely conference taking place in Amsterdam (September 2017).
- <u>VIVLI</u> aims to promote, coordinate, and facilitate clinical research data sharing through the creation and implementation of a sustainable global data-sharing enterprise. In the short term VIVLI would like to work with Cochrane on the build of the platform. In the longer term the collaboration would focus on data sharing and analysis solutions for global clinical trials data, facilitating access and discovery of data.
- <u>COMET Initiative</u> (Core Outcome Measures in Effectiveness Trials): we participated in their 6th meeting in Amsterdam in November 2016, and follow up discussions are scheduled to agree on the degree to which this partnership should be formalised. Potential areas for collaboration include work around PICO annotator and finder; and the joint work around patient and consumer engagement in identifying outcomes.
- The <u>Global Health Network</u> is a digital platform to enable research by sharing knowledge and methods. We are discussing how we can use the platform to share Cochrane Training information and resources, and possibly (at a later stage) to respond to specific training demands.

The volunteers edited 106 articles, and added over 16,000 words to these articles during a four- months' period. The articles were viewed 9.35 million times by the end of the project period (January 2017). One month later the number of views are close to 11 million. This shows the potential reach of Wikipedia. We are also working with Task Exchange and posting Wikipedia tasks on the platform. So far the response is good and tasks are getting completed on time.	 In April, we will decide whether we will continue with the volunteer scheme, with Task Exchange or with both. The pilot project with Cochrane Global Ageing will be presented at the Cochrane UK and Ireland Symposium by one of the volunteers. Another volunteer has been invited to participate in Wikimania in Canada in August to share her Cochrane Wikipedia editing experience. We are also planning a training session and poster for the Global Evidence Summit (GES) in September.
