



## Welcome message

Many people have told me, and I agree, that they regard the recent meeting of the Co-Eds Board in Geneva as being one of the most successful in recent memory. An important aspect of this success, highlighted by many, was the number of Co-Eds who led or contributed to the discussions, including some people who have not spoken so prominently before. This led to conversations that were highly relevant to the CRG community, and the sharing of ideas and perspectives in a robust but highly supportive environment. In addition, the presence and contribution of the ME, IS and Methods Executive members for large parts of the meeting seemed a very positive change.

One of the most important areas for discussion was the ongoing sustainability review. As the communications relating to the Governing Board decisions show (see below), the paper and recommendations presented by the project team were accepted in full. The team now has the task of completing the individual CRG assessments, communicating their recommendations to Groups, engaging with CRGs during the planning of networks, and developing a strategy for the implementation of networks, that includes the appointment of Senior and Associate Editors. The team will meet periodically to agree its approach. We will then be ready to engage more widely with members of the CRG community and move forward together.

## 3) Cochrane Fast-Track Service: streamlining of the application process

Author teams applying for the [Fast-Track Service](#) should now submit a draft of their review along with their [online form](#). This is to inform decisions at the triage stage – the decision to accept or reject the review for publication will not be made on the basis of this draft. If the application is then accepted onto the Fast-Track Service, authors will submit the final version via the appropriate Cochrane Review Group.

The Cochrane Fast-Track Service is a ‘journal-like’ process whereby high-quality, [MECIR](#)-compliant reviews that require no major revision, can be submitted directly into an accelerated editorial process. ## 4) Call for applications: Cochrane Review Support Programme - deadline 19 May 2017

We are pleased to announce that the fourth funding round of the Cochrane Review Support Programme (CRSP) pilot is now open. Please see the [Cochrane Community webpage](#) for more details.

There are two important changes to note with this round:

1. The number of grants has been reduced to **eight** (16 grants in total for 2017).
2. We will now offer an **extended due date for complex reviews**. The due date for standard intervention reviews remains the same and shall be not more than 12 months from the date of the award, however for reviews that include complex methodologies or topics, the due date shall be not more than 18 months from the date of the award. More details about the eligibility criteria for the extended due date are available in the [guidance](#).

It is important that applications are made using the [new form and guidance](#). Applications made using the old forms will not be accepted.

Key features of the programme:

- All Cochrane Review Groups may apply for the awards

- Groups may nominate no more than two titles – either new reviews or review updates – from the [December 2016 version of the Cochrane Priority Review List](#). Titles added to the list after December 2016 cannot be proposed for this funding round
- 8 grants of £5,000 each will be awarded
- Reviews must be published a maximum of 12 or 18 months after the awards are notified
- All successful reviews must be submitted to the CEU screening prior to publication
- The funds are intended to accelerate publication of high priority reviews/updates that are already planned or underway and will therefore meet the publication deadline
- We will aim to decide the list of successful reviews and to have notified the applicants by mid-June 2017

Cochrane recognises that these awards are insufficient to meet the full costs of conducting reviews; rather, they are intended to facilitate and possibly accelerate publication of high priority reviews that are already planned or underway.

Applications close at 5pm GMT, **Friday 19 May 2017**.
