1. Updating Classification System: release in Archie and webinars

The Updating Classification System (UCS) was released in Archie during the week of 18 July. To accompany this change, we circulated information about the UCS and presented introductory webinars. These webinars will be repeated in September.

About the Updating Classification System

The aim of the Updating Classification System (UCS) is to help readers understand whether a Cochrane Review is up to date, likely to be updated in future, or does not need updating at the current time. The system can also help Cochrane Review Groups (CRGs) with prioritization decisions for individual Cochrane Reviews.

Within the UCS, which is applied in Archie, CRGs will be able to select an Update Status for a Cochrane Review (Up to date, Updating pending, No update planned), provide a rationale for this (from a pick-list), and also add a free-text explanation to provide detail about the reason for the

selection. A decision-making flowchart is available to help guide teams to the selecting an Update Status.

The UCS uses a new publishing process in which the application and revision of the Update Status is separate from the publication of review. This means that editorial teams can revise and republish the Update Status without republishing the review (e.g. if moves to 'No update planned').

The UCS will be available for Intervention and DTA reviews initially.

2. Methods Structure and Function Review

Cochrane needs, as per the Methods Structure and Function Review, to separate two principle methods functions as methods research, evaluation and development is a separate task from providing methods support to CRGs and Centres etc. The former largely drives Methods Groups (research networks with people working to their own research agenda for which Cochrane benefits). The latter requires greater consideration and development needing a multi-level approach creating capacity and working more closely with CRGs.

1. Meetings to discuss Structure and Function Project implications for review production during Seoul Colloquium

We will be holding an extraordinary meeting of the Co-ordinating Editors Board on Sunday 23rd October in Seoul between 9.30am local time and 12.30. This will be followed by a further meeting in the afternoon between 1.30 pm and 4.30 pm, to which we would like to invite ME and IS representatives and also other CRG staff and editors.

The purpose of these meetings will be to discuss and plan implementation of the decisions agreed by Steering Group (CSG), which will meet to discuss the issue the previous day. An agenda will be circulated nearer the time, although some flexibility is inevitable given that the CSG decisions cannot be predicted in advance!

Karla Soares Weiser and David Tovey are preparing a paper to submit to CSG following the webinar consultation series in June and July. We intend to circulate a near final draft of this paper later this month, so that we can receive last minute feedback and in order to give people time to reflect on the recommendations in advance of the Seoul meetings.

We are aware that many people who will have an interest in this project will not be travelling to Seoul. Therefore, we will make arrangements for remote attendance, and will also record the meeting so that it can be viewed subsequently by people who are unable to attend. Please also bear in mind that this meeting will be the first of many, and that there will be other opportunities for CRG teams to influence the implementation plans subsequently.

2. Strategic Methods Fund – Call for proposals – Deadline September 15th 2016

A new Cochrane grant – the Strategic Methods Fund (SMF) – targets improving the implementation and use of both established and strategically important methods for Cochrane Reviews to meet the needs of healthcare policy makers, professionals and consumers by the 2020s. We will allocate 200,000 GBP each year for three successive years to fund several projects. For further information and application form.

3. MECIR Standards - Update

We will circulate revised conduct and reporting standards and new standards for protocols and updates, for Cochrane Intervention Reviews in the next few weeks. We are preparing a short summary of What's new? Methods.cochrane.org will house these standards. Please check this site for any future updates. A live version of the standards with links to resources standard by standard is in development, please check site for progress. We will make available a downloadable PDF booklet version of all the standards. We plan to produce a hard copy later this year. The main focus will be on editing intervention reviews and to explore some challenges using GRADE for Summary of Findings tables. 6. Methods Symposium 2016 Seoul Colloquium

Wednesday 26th October 9-1pm

Living systematic reviews, online summaries of healthcare research that are updated as new research becomes available, offer exciting new possibilities and challenges. Momentum is building around the living systematic review concept: a number of approaches are being piloted and Cochrane is at the forefront of these efforts.

Living systematic reviews differ from traditional systematic reviews in several ways that have important implications for review methods and processes, affecting authors, editors and publishers.

At this symposium, we will explore what living systematic reviews are, and how they might work within Cochrane. Four key sessions will be delivered focussing on living systematic review methods (what study identification looks like, and the statistical and methodological implications) and processes (production implications for authors and editors, and solving the puzzle of publishing a Cochrane living systematic review).

A case study will present the model being piloted in the first Cochrane LSR pilots, and we will

invite the audience to take part in a facilitated discussion to help shape the future of LSRs within Cochrane.
